PAYMENT POLICY (PART TWO)

The balance of your tour payment is due 60 days prior to the departure date. If the tour you select begins within 60 days of booking, final payment is due at that time.

Failure to receive the remainder of your trip balance by the due date will be considered a cancellation.

CANCELLATION / REFUND POLICIES

All cancellations must be made in writing. Cancellation fees are according to the following table:

- Cancellations received 91 or more days prior to trip start: 100€.
- Cancellations received 90 46 days prior to trip start: 300€.
- Cancellations received 45 21 days prior to trip start: 50% of trip price.
- Cancellations received 20 days or less prior to trip start: 100% of trip price.

No refunds will be issued due to the late arrival / early departure / unused portion of a tour.

All participants will receive in their confirmation packet a "Assumption of Risk / Liability Waiver" form, which must be signed and received 30 days prior to tour departure or the reservation will be treated as a cancellation.

El Camino Tours reserves the right to change, modify, or cancel a tour prior to departure for any reason, including lack of participants (minimum 4 participants) or acts of nature and/or circumstances beyond our control. In this case, any payments received will be refunded in full and this will constitute full settlement.
